Approval is restricted to those entries meeting the guidelines. The NVDF and Parade Chairman reserve the right to remove/deny any entry that does not meet the established standards. Dance teams are not authorized for the Parade. **This will be strictly enforced.**

All equestrian organizations will submit a current "Negative" Coggins Test for each horse participating in the parade along with the parade entry form. This will be strictly enforced and those entries not providing a current Coggins Test will not be permitted to participate in the parade.

Understanding that participation in the National Veterans Day Parade is completely voluntary, I, the undersigned, agree to hold harmless the National Veterans Day Organization and the City of Birmingham in the unlikely event of any accident or occurrence which causes or may cause damage or harm to yourself and/or your property and that of any others who participate as a part of your group or organization and those who may be participating in a support role of your organization and those who may be taking direction from yourself or other members of your group or organization. I also affirm and understand that no one may ride on top of or outside the confines of any vehicle participating in the parade and that at time will items (candy, trinkets etc.) be thrown from any vehicle to any parade spectators.
